2. The officers promoted on adhoc basis are not entitled to exercise option for fixation of pay and the promotion does not confer on the officers so promoted any claim for continued officiation in the grade of Inspector of Central Excise and the period of such service will not count for seniority or as qualifying service for further promotions. The officers who have already been granted financial upgradation under Assured Career Progression Scheme/Modified Assured Carrer Progression Scheme are not entitled for any fixation benefits now.

3. The promotion will be effective from the date on which the officers promoted assume charge as Inspector of Central Excise. Posting & transfer orders of the promoted officers are being issued separately. The *in situ* promotion is subject to the condition that the officer concerned joins the allocated place of posting within 15 days from the date of the said Posting & Transfer order, failing which it will treated that they have not accepted the promotion *abinitio* and all consequences arising as a result of non acceptance of promotion shall follow.

4. The above promotion is subject to the outcome of

(i) The SLP C.No.17941/2005 filed by Shri D. Raghu & others and pending before the Supreme Court of India against the orders of Hon'ble Andhra Pradesh High Court order dated 02.03.2005 in WP No.7963/2004 and batch.

(ii) The SLP CC Nos 5272-5284/2008 – Union of India Vs. A. Karunanidhi etc. filed by the department and pending before the Hon'ble Supreme Court.
