The individuals may also be informed that once they accept the fixation of seniority and furnishes the acknowledgement, representations on any discrepancy in the fixation of seniority received after the above mentioned date will not be entertained. The particulars pertaining to the columns which are left blank may also be sent to this office for incorporating the same in the seniority list at the time of its finalization.

The particulars incorporated in the Seniority lists may please be verified with the Service Books of the officers concerned and the result of such verification duly recorded in the prescribed certificate (enclosed) and be sent to this office, within one month from the date of issue of this letter. The present place of posting may also please be checked and if any discrepancy found, the correct place of posting as on 01.08.2011 may please be reported.

5. Further they may be informed that the seniority list now issued is subject to outcome of pending cases, if any, in various judicial forums.
