LIMITED TENDER NOTICE

In connection with the observance of "Swacchta Action Plan" this Office proposes to Construct four toilets in the Maraimalai Adigal Government Higher Secondary School, Pallavaram, Chennai.

1. Contractors possessing the requirements as under may submit their quote to undertake the below mentioned work.
2. Interested parties possessing the infrastructure for completing the work mentioned below may visit our Official Web-Site www.centralexcisechennai.gov.in for details. The parties may visit the Government higher Secondary School located at Pallavaram, Chennai and may inspect the premises on any working day after consultation with the Headmistress of the school under intimation to the Assistant Commissioner (Administration), GST & Central Excise Appeal I Commissionerate, Chennai-600034.

The quotes should include a detailed report with the cost of materials, labour and transportation charges. The quote should be for construction of four toilets with the following specifications.

- 1) Toilets to be made with Pillars of 1' x1' (lxb) six nos. and with height of 11 feet.
- 2) Brick Work all around with concrete 0'-9' for nearly 500 Sq. feet.
- 3) Cement sheet for the ceiling should be used with PVC doors.
- 4) Indian closet to be used
- 5) Water Pipe line with metal taps and all other necessary accessories to be used.
- 6) Tiles for the walls up to 5 feet and also for flooring tiles to be used.
- 7) Proper plumbing Electrical and Painting work have to be done

Interested parties should possess the following eligibility criteria.

- (i) They should be registered with GST department, with PAN number and have experience in similar nature of work. Copies of GST Registration and PAN card should be enclosed with the quotation.
- (ii) No advance shall be paid and hundred percent of the amount will be paid only on completion of the work.

The envelope containing the quotation should be superscribed as, '**QUOTATION FOR CONSTRUCTION OF TOILETS**' and should be addressed to The Commissioner, Office of the Commissioner of GST and Central Excise, Appeals I Commissionerate, Chennai -34. The quotation should be submitted in a sealed cover and should reach the undersigned on or before 12.09.2019 by 14.00 hrs.
