#### Inspection:

1. The service Provider possessing the necessary infrastructure for scanning and digitisation work mentioned above may visit our Official Web-Site <u>www.centralexcisechennai.gov.in</u> for details. The Parties may visit the Office of the Commissioner of GST & Central Excise, Appeals I Commissionerate, GST Bhavan, II Floor, Nungambakkam, Chennai-600034 and inspect the files/records for digitisation on any working day under intimation to the Assistant Commissioner (GST & Central Excise), Administration wing, Appeals I Commissionerate, Chennai-600034.

#### Quotation:

The Quotation should include a detailed report with the cost of the scanning & digitization work including GST applicable. The quote should be for the scanning & digitization of office records with price quoted as per scanned image.

- 1. Scanning should be as per the department's required format and resolution typically upto 200 dpi resolution in Black & white or Grey and 300 dpi for colour mode.
- 2. Naming of the file should be as per the department's requirement,
- 3. Output should be in searchable PDF format. Page size A4/Legal, Paper Range: About 1,00,000 pages.
- 4. Work should be undertaken in the office premises only. Department will provide space & power supply.
- 5. Service provider must arrange for High end Scarmers & Manpower to undertake the scanning job. The Job should be completed within **one** month from the date of execution of work order.

6. Data back up as per the department's requirements. Data burning charges are inclusive.

Interested parties should possess the following eligibility criteria.

- (i) They should be registered with GST department, with PAN number and have experience in similar nature of work.
- (ii) No advance shall be paid and hundred percent of the amount will be paid only on completion of the work.
