The Commissioner of Central Excise, Chennai II Commissionerate will be the Chairperson (Ex-officio) of the Committee. The Additional Commissioner (Technical), Chennai II will be the Secretary (Ex-officio) of the Committee.

The term of Office of the permanent members to the Committee is valid upto 31.12.2007.

The Committee shall meet once in three months or as often as the Chairperson may decide. The date, time and venue of the meetings will be communicated to the members in advance.

The functions of the committee are purely advisory in nature and are intended for resolving procedural difficulties brought to notice by the members. Members are requested to take active interest and bring to the Committee's notice all genuine grievances in relation to tax administration and prescribed procedures and other day to day matters on behalf of the concerned industry sector.

No member other than the nominated members will be allowed to sit in the meetings. Any member who is continuously absent from three meetings (without adequate reasons) shall be deemed to have withdrawn himself from the committee and fresh nomination will be made in his place.

TA and DA admissible to members of the committee will be regulated in accordance with the Rules in force.
